A PROPOSAL TO INCREASE ACADEMIC SCHOLARSHIP MONTHLY STIPEND OF UNDERGRADUATE FULL SCHOLARS AND ACES SCHOLARS EFFECTIVE FIRST SEMESTER SY 2002-2003

A. Rationale

The granting of undergraduate academic scholarships has been part of the incentives and awards program of Leyte State University (LSU) to students who have excelled in their academic work. For decades now, the privileges offered, particularly the monthly stipend to Full/Partial/Entrance scholars have not been at par with the privileges offered by other colleges and universities in the country.

If the university intends to attract and motivate the best graduates from different secondary schools to enroll at LSU, the privileges that we should offer through these scholarships should be competitive with those offered by other institutions.

There is a need, therefore, to increase the monthly stipend for full scholarships (Entrance and Continuing) from P425.00 per month to P600.00 and from P425.00 to P800.00 per month (ACES) effective First Semester SY 2002-2003 to make it more sufficient for the scholars to meet their basis needs.
