**BOR RESOLUTION NO. 2, s. 2007**

**A RESOLUTION CONFIRMING  
THE LIST OF CANDIDATES FOR  
GRADUATION OF THE MAIN CAMPUS  
FOR THE 2<sup>nd</sup> SEMESTER, SY 2006-2007**

**WHEREAS**, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

**WHEREAS**, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

**WHEREAS**, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: "Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292";

**WHEREAS**, the College Academic Councils of the Main Campus has reviewed and recommended the list of candidates for graduation for the 2<sup>nd</sup> Semester, SY 2006-2007 to the University Academic Council for further refinement; and

**WHEREAS**, the University Academic Council met on 06 February 2007 for the purpose of reviewing the list of candidates for graduation of the different colleges of the Main Campus for the 2<sup>nd</sup> Semester SY 2006-2007 and have found the list of candidates for graduation to be in order and have recommended to the LSU Board of Regents the lists of candidates of graduation for approval, *provided that* the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2006-2007.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the list of candidates for graduation for the Main Campus for the 2<sup>nd</sup> Semester, SY 2006-2007 *provided that* the candidates shall have complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2006-2007.






