**SPECIAL BOR RESOLUTION NO. 3, s. 2010**

**A RESOLUTION AMENDING SPECIAL BOR RESOLUTION NO. 1, s. 2010  
APPROVING THE AWARD TO DR. MANUEL K. PALOMAR  
THE HONORARY TITLE OF PROFESSOR *EMERITUS***

**WHEREAS**, Section 7, Paragraph (k) of R.A. 9158 empowers the Governing Board “to award honorary degrees upon persons in recognition of outstanding contribution in the field of agriculture or any field of specialization within the academic competence of the University; and to authorize the award of certificates of completion for non-degree and non-traditional courses”;

**WHEREAS**, the records of Dr. Manuel K. Palomar, as a person and as a professional, have been carefully scrutinized by the University and the Board of Regents and have been found to have satisfied all requirements attendant to the grant of the honorary title of Professor *Emeritus*;

**WHEREAS**, the VSU Board of Regents passed Special BOR Resolution No. 1, s. 2010 on the occasion of the 46<sup>th</sup> BOR Meeting held at the LNU Conference Hall, Tacloban City last 16 February 2010 conferring upon Dr. Manuel K. Palomar the honorary title of Professor *Emeritus*;

**WHEREAS**, Section 185 of the ViSCA Code provides, to wit: “A retired professor may be appointed professor emeritus if he has rendered at least twenty (20) years uninterrupted active and faithful service to the college and has shown marked distinction as a productive scholar, scientist, or educator or is widely acknowledged as an effective and dedicated teacher; Provided, That the department head and the ranking professors in his discipline in the college to which he belonged, recommended by unanimous vote and with a written justification, his appointment to the president of the college who, in his discretion, may submit the recommendation to the Board of Trustees for approval”; and


**WHEREAS**, in deference to Section 185 of the ViSCA Code, required specifically required, to wit: “...Provided, That the department head and the ranking professors in his discipline in the college to which he belonged...” the VSU Board of Regents has deemed it necessary to qualify the honorary title being accorded to Dr. Manuel K. Palomar to Professor *Emeritus* in Plant Protection.




