**A RESOLUTION CONFIRMING THE NEW APPOINTMENTS
OF TWO (2) CONTRACTUAL ACADEMIC STAFF FROM THE MAIN

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*";

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the renewal of the selected contractual academic staff;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management Office (HRMO) has recommended to the University President the renewal of following academic staff with Contractual appointments:
