**A RESOLUTION  
APPROVING THE SABBATICAL  
LEAVE APPLICATION OF DR. VICTOR B. ASIO**

**WHEREAS**, Dr. Victor B. Asio has a Letter of Invitation from Dr. Zueng-Sang Chen, Associate Dean of the College of Bioresources and Agriculture, National Taiwan University, Taipei, Taiwan for the conduct of research on Soil-Landscape Relationship in Taiwan which is funded by the National Science Council of the Republic of China, Taiwan;

**WHEREAS**, the Visayas State University has an existing tie-up with the National Taiwan University for the exchange of faculty especially for the purpose of academic pursuits;

**WHEREAS**, the National Science Council of Taiwan will pay for the cost of the round trip air tickets, nine months of local living allowance and research budget requested by Dr. Asio during his Sabbatical Leave;

**WHEREAS**, it is expected that the research results will redound to better understanding of the ecological researches being conducted by VSU in Mt. Pangasugan, Leyte since the conditions are very similar with that in Taiwan;

**WHEREAS**, the research collaboration between VSU and NTU will be greatly enhanced with the conduct of the research by Dr. Asio in Taiwan;

**WHEREAS**, the University Academic Personnel Board is strongly recommending the approval of the Sabbatical Leave application of Dr. Victor B. Asio;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the Sabbatical Leave of Dr. Victor B. Asio to the Natinal Taiwan University, Taipei, Taiwan effective 01 November 2007 until 31 October 2008.






