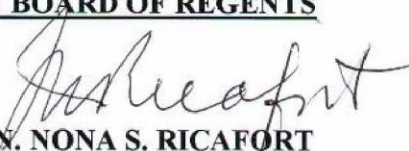
WHEREAS, the University President has approved the renewal of appointments of the appointees and is recommending to the Board of Regents the confirmation of the issued appointments.

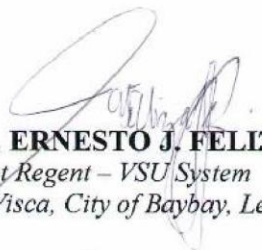

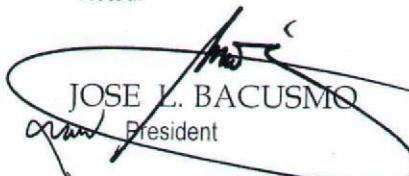

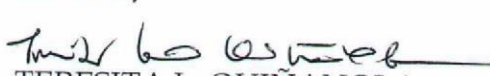
