**BOR RESOLUTION NO. 88, s. 2011**

**A RESOLUTION CONFIRMING THE RENEWAL OF  
APPOINTMENTS OF TEN (10) CONTRACTUAL ACADEMIC  
FACULTY FROM THE MAIN CAMPUS AND EXTERNAL CAMPUSES  
SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING  
SUCH APPOINTMENTS**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board “*to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University*”;

**WHEREAS**, the Visayas State University needs to renew the contracts of qualified academic faculty to teach the different courses in the University;

**WHEREAS**, the College Deans through the Vice President for Academic Affairs have recommended the renewal of appointments of the ten (10) contractual academic faculty;

**WHEREAS**, Office of the Director of Administration and Human Resource Development (ODA-HRD) and the University Academic Personnel Board (APB) have gone over the qualifications of the appointees and have recommended to the University President the renewal of appointments charged to Lump Sum appropriation;

**WHEREAS**, the University President has approved the renewal of appointments of the selected academic faculty charged to Lump Sum appropriation and is endorsing to the Board of Regents the Confirmation of said appointments *subject to* existing rules, regulations and guidelines governing such appointments, as follows:




