**A RESOLUTION APPROVING THE REQUEST OF PRESIDENT EDGARDO E. TULIN  
FOR AUTHORITY TO TRAVEL TO BUDAPEST, HUNGARY FOR THE PERIOD 10  
DECEMBER 2017 UNTIL 15 DECEMBER 2017 *SUBJECT TO* EXISTING RULES AND  
REGULATIONS GOVERNING FOREIGN TRAVELS BY GOVERNMENT OFFICIALS**

**WHEREAS**, the VSU President, Dr. Edgardo E. Tulin has been invited by the Commission on Higher Education (CHED) as part of the Philippine delegation headed by CHED Chairperson Patricia B. Licuanan to participate in the "1<sup>st</sup> Joint Working Group (JWG) Meeting" organized by the Ministry of Human Capacities, Hungary;

**WHEREAS**, the JWG Meeting will discuss the "Implementation of the Educational and Scientific Exchange Programme between the Commission on Higher Education of the Republic of the Philippines and the Ministry of Human Capacities of Hungary for the years 2018, 2019 and 2020;

**WHEREAS**, the Meeting will be held in Budapest, Hungary from 10 December 2017 until 15 December 2017;

**WHEREAS**, Section 7(*t*) of R.A. 9158 specifically empowers the VSU Board of Regents to "*develop academic arrangements for institutional capability building with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be*"; and

**WHEREAS**, the travel expenses for this trip to Hungary shall be shouldered by the University subject to the usual accounting and auditing rules and regulations.

**NOW, THEREFOR, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to Approve the request of President Edgardo E. 
