BOR RESOLUTION NO. 32, s. 2009

**A RESOLUTION AFFIRMING
THE IMMEDIATE IMPLEMENTATION OF
BOR RESOLUTION NO. 12, s. 2009 DATED 03 FEBRUARY 2009**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "*to fix and adjust salaries of faculty members and administrative officials and employees subject to the provisions of the Revised Compensation and Position classification System and other pertinent budget and compensation laws governing hours of service, and such other duties and conditions it may deem proper; to grant them, at its own discretion, leaves of absence under such regulations as it may promulgate, any provisions of existing law to the contrary notwithstanding, and to remove them for cause in accordance with the requirements of due process of law*" as stipulated in Item (h), Section 7 of R.A. 9158;

WHEREAS, the VSU Board of has passed BOR Resolution No. 12, s. 2009 dated 03 February 2009 on the occasion of the 42nd BOR Meeting held at the Leyte Normal University Conference Hall, Tacloban City;


WHEREAS, the VSU Board of Regents very clearly disapproved the continued deployment of Dr. Antonio L. Acedo, Jr with the AVRDC and directed the University President, Dr. Jose L. Bacusmo, to immediately issue a recall order against Dr. Acedo;

WHEREAS, the VSU Board of Regent took up and discussed Dr. Acedo's Request for Reconsideration on the occasion of the 43rd BOR Meeting and the Board of Regents has affirmed its decision on the recall of Dr. Acedo from the Asian Vegetable Research and Development Center, effective immediately;



Acedo, Jr. at the Asian Vegetablen Research and Development Center (AVRDC) and authorizing the immediate recall of Dr. Acedo back to the Visayas State University.
