BOR RESOLUTION NO. 86, s. 2015

A RESOLUTION APPROVING THE PROMOTIONAL APPOINMENT OF DR. EDGARDO E. TULIN TO THE POSITION OF SUC PRESIDENT IV FOR A TERM OF FOUR (4) YEARS COMMENCING ON 30 OCTOBER 2015 UNTIL 29 OCTOBER 2019, WITH ALL THE POWERS, RIGHTS, RESPONSIBILITIES AND PRIVILEGES THERETO APPERTAINING

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437:

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 9 of R.A. 9158 specifically provides: "The University shall be headed by a President who shall render full-time service. He shall be appointed by the (Governing) Board upon the recommendation of a duly-constituted Search Committee. He shall hold office for a term of four (4) years, extendible only for another four (4) years";

WHEREAS, the VSU Board of Regents (BOR) passed BOR Resolution No. 37, s. 2015 otherwise known as "<u>A Resolution Approving the Guidelines in the Selection of the University President of the Visayas State University</u>" on the occasion of the 70th BOR Meeting held at the LNU Conference Hall, Leyte Normal University, Tacloban City, Leyte last 16 June 2015;

WHEREAS, the CHED Commissioner Maria Cynthia Rose B. Bautista, *PhD*, Chairperson-Designate of the VSU BOR constituted a Search Committee for the Presidency by way of a CHED Memorandum dated 10 august 2015;

WHEREAS, the duly-constituted Search Committee for the Presidency (SCP) actively campaigned and searched out for possible applicants as indicated in BOR 37, s. 2015;

WHEREAS, the SCP caused the placement of an advertisement in a newspaper of national circulation announcing the Search for the Next VSU President;

WHEREAS, at the designated deadline for the submission of applications last 30 September 2015, there were three (3) applicants for the vacancy;

WHEREAS, the SCP conducted a series of activities for the purpose of carefully screening the applicants for the VSU Presidency;

- **WHEREAS**, after the course of the series of activities and after four (4) SCP meetings, the SCP was able to evaluate the three candidates for the Presidency;
- WHEREAS, the BOR took the opportunity to get to know better the applicants by conducting a short interview with all the applicants for the VSU Presidency;
- **WHEREAS**, the BOR also took the opportunity to hear the Final Report of the Search Committee which made a very thorough evaluation of the potentials of each of the applicants;
- **WHEREAS**, the BOR, after due diligence and intense introspection, cast their votes to elect the next VSU President;
- **WHEREAS**, the said activity caused the election of Dr. Edgardo E. Tulin as the next President of the Visayas State University; and
- WHEREAS, Dr. Edgardo E. Tulin has indicated his willingness to accept all the position of SUC President IV of the Visayas State University "with all the powers, rights, responsibilities and privileges thereto appertaining".
- THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the appointment of Dr. Edgardo E. Tulin to the position of SUC President IV of the Visayas State University for a period of four (4) years commencing on 30 October 2015 until 29 October 2019, with all the powers, rights, responsibilities and privileges thereto appertaining.
