#### BOR RESOLUTION NO. 49, s. 2016

## A RESOLUTION CONFIRMING THE DESIGNATION OF MS. RAZA CRECIA L. MENESES AS DEAN OF THE COLLEGE OF NURSING, VSU MAIN CAMPUS SUBJECT TO EXISITING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, there is a need to immediately come up with new appointees to fill vacancies whenever such vacancies arise to ensure the efficient and effective delivery of its services to its clientele;

**WHEREAS**, the designated Dean of the College of Nursing is currently on scholarship for her doctorate degree in Nursing effective June 2016;

WHEREAS, the University has found it necessary to designate Ms. Raza Crecia L. Meneses to be the Dean of the College of Nursing, VSU Main Campus effective 06 June 2016 until 31 December 2016 or unless sooner terminated by higher authorities; and

**WHEREAS**, the University President is endorsing the designation of Ms. Meneses as Dean of the College of Nursing, VSU Main Campus, to the Board of Regents for Confirmation, subject to existing rules, regulations and guidelines governing such designations.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to confirm the designation of Ms. Raza Crecia L. Meneses as Dean of the College of Nursing, VSU Main Campus effective 06 June 2016 until 31 December 2016 *subject to* existing rules, regulations and guidelines governing such designations.
