BOR RESOLUTION NO. 37, s. 2007

**A RESOLUTION APPROVING
THE PROPOSED ADDITIONAL INCENTIVES
FOR PROFESSOR EMERITUS GRANTEES**

WHEREAS, BOR Resolution No. 103, s. 2003 provides for the General Guidelines on the Grant of Professor Emeritus status on LSU retirees;

WHEREAS, the existing incentives granted to retirees accorded Professor Emeritus status include: a) free use of University facilities such as the library, office space, etc.; housing is excluded in this privilege; b) gasoline allowance of not more than P2,000.00 per semester; c) free use of office supplies needed for teaching and making of proposals; d) attendance in conferences, workshops, meetings related to instruction may be supported based on budget and justification;


WHEREAS, on account of the dramatic increase in the cost of living including the rising price of petroleum products, there is a felt need to increase the benefits given to *Professor Emeritus* grantees, as follows: a) increase in gasoline allowance from P2,000.00 per semester to P5,000.00 per semester *provided that* the grantee stays on campus for consultation, research, advising, etc. at least twice a week; and b) he/she be paid P500.00 per hour for actual teaching following the rate set by the Civil Service Commission as honorarium for expert services;


WHEREAS, the University Administrative Council during its 62nd Meeting held last 27 March 2007 has strongly recommended approval of the said increase in benefits for *Professor Emeritus* grantees.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed increase in benefits for Professor Emeritus grantees effective upon BOR approval.
