## A RESOLUTION CONFIRMING THE RECLASSIFICATION OF SOME ADMINISTRATIVE STAFF

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the University regularly upgrades administrative positions whenever there are savings from personnel services brought about by the abolition of positions, both academic as well as administrative, which is then used to create new positions and/or upgrade positions;

WHEREAS, the Non-Academic Personnel Board (NAPB) has gone over the employees who have qualified for the different plantilla positions and has determined that the employees nominated therein, are more than qualified for the positions stated;

WHEREAS, the Governing Board, is convinced that the recommendations of the NAPB are fair and adhere to thrust of government that only the best and the most fit should be in the government service;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the reclassification of the following employees of the University, effective on the dates indicated:
