A RESOLUTION APPROVING THE
ADOPTION OF THE APPROVED MATHEMATICS
COURSES OF THE BACHELOR OF GEODETIC ENGINEERING
(BSGE) PROGRAM IN THE BACHELOR OF CIVIL ENGINEERING (BSCE)
PROGRAM, EFFECTIVE 1<sup>ST</sup> SEMESTER, SY 2011-2012 PROVIDED THAT MATH 15
(PLANE AND SPHERICAL TRIGONOMETRY) IS NOT OFFERED IN THE SAME
SEMESTER AS MATH 13 (COLLEGE ALGEBRA AND TRIGONOMETRY)



WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (i) of R.A. 9158 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 11 of Republic Act No. 9158 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, subject to review and/or approval of the Board of Regents/Trustees through the President of the university or college";

**WHEREAS**, the CHED issued CMO No. 29, s. 2007 for the Bachelor of Science in Civil Engineering and CMO No. 12, s. 2008 for the Bachelor of Geodetic Engineering;

WHEREAS, the VSU Board of Regents passed BOR Resolution No. 30, s. 2009 dated 01 July 2011 entitled: "Approving the Proposal to Revise the BS Geodetic Engineering Curriculum in compliance with CMO No. 12, s. 2008" on the occasion of the 43<sup>rd</sup> BOR Meeting held at the LNU Conference Hall, Tacloban City, Leyte

WHEREAS, there is a need for the BS Civil Engineering program to adopt the approved mathematics courses in the approved BS Geodetic Engineering program in order for it to be fully compliant with CMO No. 29, s. 2007; and

WHEREAS, the University Academic Council (UAC) has discussed and approved this proposal on the occasion of the 29<sup>th</sup> UAC meeting held at the University Convention Center last 03 October 2011 and passed UAC Resolution No. 24, s. 2011 "Approving the Proposal to Adopt the Approved Mathematics Courses of the BS Geodetic Engineering in the BS Civil Engineering, effective 1<sup>st</sup> Semester, SY 2011-2012 Provided That, Math 15 (Plane and Spherical Trigonometry) is
