WHEREAS, Section 7, Paragraph (J) of R.A. 9158 empowers the Governing Board “to set policies on admission and graduation of students”;



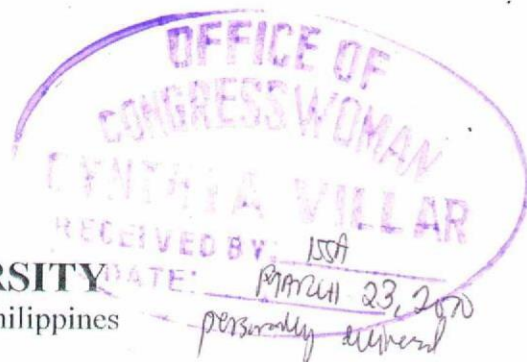


