WHEREAS, the Board of Regents is granted the power to appoint upon recommendation of the University President vice-presidents, deans, directors and heads of campuses, faculty members, and other officials and employees of the University;

WHEREAS, as provided by law, the Board of Regents could delegate the abovementioned power to the university President as it may deem appropriate, so as to expedite the administration of the affairs of the University;

WHEREAS, pursuant to the Board Resolution No. 14, s. 2006 which granted the University President the authority, among others, the authority to designate deans, campus directors, department chairs and other heads of principal units; and to designate program and project directors/coordinators;

WHEREAS, pursuant to the aforesaid Board resolution, the University President designated faculty and staff to administrative functions from March to May 2024 per attached list, with relevant documents presented at the meeting of the University Administrative Council on May 23, 2024 and obtained favorable endorsement;

WHEREAS, finding the UADCO's recommendation in order, the Governing Board has agreed to approve the proposal;

NOW, THEREFORE, on motion, duly seconded, and unanimously approved, be it;

RESOLVED, as it is hereby resolved, that the Board of Regents of Visayas State University confirms the designations issued by the Office of the University President to faculty and staff for various positions to perform the duties and functions as specified in their respective designations in addition to the regular duties and functions of the plantilla positions to which they were appointed to, per list hereto attached and made part hereof.
