**BOR RESOLUTION NO. 57, s. 2012**

**A RESOLUTION APPROVING THE PROPOSAL  
TO AMEND SECTION 17.3 (RESIDENCY REQUIREMENT AND  
TIME LIMIT) OF ARTICLE VII (ACADEMIC AND OTHER REGULATIONS)  
OF THE GRADUATE SCHOOL CODE OF THE VISAYAS STATE UNIVERSITY**

**WHEREAS**, the Visayas State College of Agriculture (ViSCA) was converted into the Leyte State University (LSU) by virtue of Republic Act 9158 last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, among other powers granted to the Board of Regents is the power "*to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University*" as stipulated in Section 7, Paragraph (a) of R.A. 9158;

**WHEREAS**, the Graduate School Code was last amended in 2003 with the passage of BOR Resolution No. 52, s. 2003;

**WHEREAS**, the Office of the Dean of Graduate School has found it necessary to update the Residency Requirement and Time Limit for students pursuing Graduate Degrees in the Visayas State University;

**WHEREAS**, Section 11 of R.A. 9158 stipulates that it is the duty of the Academic Council "*...to review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...*";

**WHEREAS**, Item a of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 empowers the Academic Council to: "*Determine, review and recommend for the approval of the Governing Board the course offerings of the concerned chartered SUC and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (i) of R.A. 8292*";


**WHEREAS**, the University Academic Council met last 15 November 2012 for the purpose of reviewing the proposal to amend the Graduate School Code specifically Article VII, Section 17.3 and found the proposal to be in order and has endorsed the proposal to the VSU Board of Regents for Approval; and


**WHEREAS**, the Governing Board thoroughly discussed the merits of the proposal and found it in order.
