PROPOSAL TO INCREASE UNDERGRADUATE
SCHOLARSHIP EXAMINATION FEE

BOR Resolution No. 75, s. 2002

Approving the proposal to increase Undergraduate
Scholarship Examination Fees as modified.

The Board suggested that the fees for the undergraduate scholarship examination should be based on the income level of the students, as follows:

- a) P50.00 - for students with family income of not more than P60,000.00 per annum
- b) P 100.00 - for students with family income of between P60,001.00 to not more than P80,000.00 per annum
- c) P 150.00 - for all other students, including faculty and staff dependents, with family income of more than P80,000.00 per annum


The students shall be required to present Tax Return of parents. The collection of increased examination fees will start October 1, 2002.

A PROPOSAL TO INCREASE UNDERGRADUATE SCHOLARSHIP EXAMINATION FEES

A. Rationale

For several years now, the Leyte State University (LSU) has been collecting relatively low examination fees for undergraduate scholarship, namely: Advanced Credits for Exceptional Students (ACES), and Undergraduate Entrance Scholarship. Correspondingly, the scholars are granted limited privileges and incentives that can adequately compete with other colleges/universities. The present practice has lost LSU's opportunity to compete with other colleges and universities in the Visayas and Mindanao regions such as Silliman University, Xavier University, Central Mindanao University and others that collect higher examination fees at a minimum rate of P250.00, and consequently provide, higher rate of stipend and other privileges for their academic scholars.

There is a need, therefore, to increase the LSU scholarship examination fees and the scholars' privileges to be at par with other universities. The increased fees to be collected shall be plowed back to the existing undergraduate scholarship fund to pay initially the increase of the undergraduate full scholars' monthly stipend. It is anticipated that in the event the financial landscape of the University for undergraduate scholarship program shall have been improved, the stipend of partial scholars and other University-funded scholarships be likewise upgraded. With this projected upgrading, hopefully, it shall entice incoming freshmen and academic scholars to enroll in the University for good.

C. Implementation

The collection of increased examination fees will be effective October 1, 2002.
