**BOR RESOLUTION NO. 12, s. 2023**

**A RESOLUTION APPROVING THE UTILIZATION OF THE 2022 GAA FLR PROJECT  
ENTITLED: CONDUCT OF ACTIVITIES FOR SPORTS AND CULTURE DEVELOPMENT**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to *“exercise all the powers granted to the Directors of a corporation under Section 36 of Batas Pambansa Blg. 68 otherwise known as the Corporate Code of the Philippines”*;

**WHEREAS**, Paragraph (b), Section 7 of R.A. 9158 provides: *“To receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University”*;

**WHEREAS**, VSU is a CHED Center for Excellence (COE) in Agriculture and a National University in Region VIII, it is mandated to provide leadership in developing highly competitive human resource, relevant scientific knowledge, and innovative technologies to support the sustainable development of the Visayas Region in particular and the whole of the Philippines in general;

**WHEREAS**, the request for BOR approval is on the release of the For Later Release (FLR) incorporated in the 2022 General Appropriations Act (GAA) of Visayas State University as a support to the effective implementation of GAA Approved Project on the Conduct of Activities for Sports and Culture Development;

**WHEREAS**, funds requested to be approved was a budget insertion and identified under the MOOE under the account title Maintenance and Other Operating Expenses with a total of five hundred thousand pesos (P500,000.00);

**WHEREAS**, CHED and DOH had already allowed the resumption of collegiate athletic competitions and cultural presentations, the funds could augment the capacity of the university in the procurement of sports equipment, other things needed for sports and cultural activities, especially the activities of the varsity program;

**WHEREAS**, maintenance of sports facilities and equipment could also be addressed once the proposal would be approved.;

**WHEREAS**, the proposal was discussed and endorsed by the University Administrative Council during its March 23, 2023 meeting to the VSU BOR Finance Committee

**WHEREAS**, the VSU BOR Finance Committee discussed the proposal and endorsed the same to the Full Board for approval during a hybrid committee meeting on 11 April 2023.

**Resolved as it is thereby resolved to APPROVE the Utilization of the 2022 GAA FLR Project entitled: Conduct of Activities for Sports and Culture Development.**




