#### BOR RESOLUTION NO. 11, s. 2013

## PROPOSAL TO INCREASE THE MONTHLY RENTAL IN ALL VSU STUDENT COTTAGES AND DORMITORIES AMOUNTING TO P50.00 PER MONTH FOR SY 2013-2014 AND ANOTHER P50.00 PER MONTH FOR SY 2014-2015

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, among the other powers of the GB as provided for Section 7 (d) of R.A. 9158 stipulates, to wit: "to fix the tuition fees and other necessary school fees and charges, such as, but not limited to matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors...";

WHEREAS, the University has put up 27 cottages and dormitories located in different parts of the University Main campus with a combined capacity of about 1,700 students to serve the housing needs of students coming from far places and help mold the students into well-rounded individuals;

WHEREAS, the University Student Services Office (USSO) has been tasked by University to overseethe management and operations of these cottages and dormitories to ensure that these are safe and well maintained despite having most of the structures built over the last 30 years;

WHEREAS, the cost of repairs and maintenance, including the cost of materials and labor, have spiraled beyond the capacity of USSO to operate and maintain considering the very low monthly rentals charged to the students;

WHEREAS, the engineers of the General Services Division of the University has estimated that an increase in the monthly rental by P50.00/student in SY 2013-2014 and another P50.00/student for SY 2014-2015 across all cottages and dormitories will be sufficient to maintain these structures;

WHEREAS, the proposal of the USSO to increase the monthly student rental by P50.00 for SY 2013-2014 and P50.00/student in SY 2014-2015 for all cottages and dormitories of the University was presented to the University Administrative Council (UADCO) on the occasion of its 100<sup>th</sup> UADCO Meeting held last 27 February 2013 at the University Review Center, VSU Main Campus, Visca, City of Baybay, Leyte; and

**WHEREAS**, the UADCO unanimously approved the University Academic Calendar, as proposed and is strongly endorsing the same to the VSU Board of Regents for **Approval**.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the proposal to increase the monthly student rental by P100 for all cottages and dormitories of the University, as proposed, effective Summer, SY 2012-2013.
