A RESOLUTION CONFIRMING THE GRANT OF THE *LATIN HONOR OF CUM LAUDE* ON MR. NICO S. WHEREAS, the University Academic Council, by way of Referendum, reviewed the list containing the lone candidate for graduation with *Latin Honors*, for the 1st Semester, SY 2016-2017;

WHEREAS, the University Academic Council has determined that Mr. Nico S. Risos – a student graduating with the degree of Bachelor of Secondary Education – has qualified for the *latin honor of Cum Laude*; and

WHEREAS, the University Academic Council is strongly endorsing award of the *Latin honor of Cum Laude* on Mr. Nico S. Risos to the VSU Board of Regents for **Confirmation**, *Provided that*, the candidate has complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for the 1st Semester of School Year 2016-2017.
