**BOR RESOLUTION NO. 77, s. 2007**

**A RESOLUTION  
CONFIRMING THE LONE  
CANDIDATE FOR GRADUATION WITH HONORS  
OF THE MAIN CAMPUS FOR THE 1<sup>st</sup> SEMESTER SY 2007-2008**

**WHEREAS**, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board “to set policies on admission and graduation of students”;

**WHEREAS**, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: “... It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college”;

**WHEREAS**, Item c of Section 39 of CHED Memorandum No. 3, s. 2001 dated 21 January 2001 stipulates, to wit: “Fix the requirements for the admission of students in the concerned chartered SUC as well as for their graduation and the conferment of degrees and submit the same to its GB for review and/or approval in accordance with Section 4, Paragraph (j) of R.A. 8292”;


**WHEREAS**, the College Academic Council of the College of Engineering and Agri Industries of the Main Campus has reviewed and recommended the lone candidate for graduation *with* Honors for the 1<sup>st</sup> Semester SY 2007-2008 to the University Academic Council for further refinement; and

**WHEREAS**, the University Academic Council approved, through a Referendum, the list of candidates for graduation *with* Honors of the different colleges of the Main Campus for the 1<sup>st</sup> Semester of SY 2007-2008 and has found that there is only one candidate for graduation with Honors and has recommended the same to the VSU Board of Regents, *provided that* the candidate has complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2007-2008.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the lone candidate for graduation *with* Honors from the Main Campus for the 1<sup>st</sup> Semester SY 2007-2008 *provided that* the candidate has complied with all the requirements for graduation on or before the deadline indicated in the approved Academic Calendar for School Year 2007-2008.
