# A RESOLUTION CONFIRMING THE DIFFERENT MEMORANDUM OF AGREEMENT (MOAs) ENTERED INTO BY THE VISAYAS STATE UNIVERSITY (VSU) WITH VARIOUS ENTITIES

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University" as stipulated in Item (s), Section 7 of R.A. 9158;

WHEREAS, the Visayas State University finds it advantageous to have entered into these different Memorandum of Agreement (MOAs) with various entities as it has provided benefits to the University and its constituents;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the various Memorandum of Agreement (MOAs) entered into by the Visayas State University and various entities.
