A RESOLUTION APPROVING THE ADOPTION OF CHED MEMORANDUM ORDER (CMO) NO. 30, s. 2004 (BACHELOR OF ELEMENTARY EDUCATION – BEEd AND THE BACHELOR IN SECONDARY EDUCATION - BSEd)

WHEREAS, the Commission on Higher Education (CHED) issued CMO No. 30, s. 2004 also known as "Revised Policies and Standards for the Bachelor of Elementary Education and the Bachelor of Secondary Education" in order to implement the new BEEd and BSEd curricula;

WHEREAS, Section 4, Paragraph (j) of R.A. 8292 empowers the Governing Board "to set policies on admission and graduation of students";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "It shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college *subject to* appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, the University Academic Council (UAC), approved the adoption of CMO 30, s. 2004, on the occasion of its 25th UAC Meeting held last 25 March 2010 at the First Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the request of the Dean of the College of Education, VSU Main Campus, for the immediate implementation of the new BEEd and BSEd curricula in accordance with CMO 30, s. 2004.
