**A RESOLUTION APPROVING THE
CREATION OF A UNIVERSITY PROFESSOR POSITION
BY ABOLISHING A VACANT PROFESSOR 6 POSITION (WITH ITEM
NO. PROF. 6-17-1998) AND SUBJECT TO EXISTING RULES,
REGULATIONS AND GUIDELINES**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, par. V3.2 of the National Budget Circular (NBC) 461 stipulates, to wit: "*there will be one (1) University Professor position every six (6) years but not to exceed 5% of the total number of accredited Full-Professors in the University*";

WHEREAS, the University presently has 61 faculty members occupying the academic rank of *Full Professor* and based on 5% of the total number of Full Professors, is entitled to have three (3) active University Professor positions in addition to one (1) position for SUC Executive;

WHEREAS, there are three (3) University Professor positions occupied by qualified faculty pursuant to the rules and guidelines of NBC 461;

WHEREAS, Section 4.1.2 of NBC 461 and as clarified in a DBM letter to the PASUC dated 13 October 1995 indicated:

"that SUC Executives who opt to return to the academe after the expiration of the fixed-term of office, may be appointed as College/University Professor, in addition to the slot available for deserving faculty members, *Provided, that* they have complied with the requirements under section 3.0 of the said Circular, due to their resignation/retirement not for cause, before the expiration of their fixed term of office."

WHEREAS, the University is requesting the Department of Budget and Management (DBM) to create an additional University Professor item through the abolition of the vacant PROF. 6 position, with item no. Prof. 6-17-1998, which was previously occupied by Dr. Rolinda T. Sanico who retired from government service last 31 December 2010.

WHEREAS, the Department of Budget and Management (DBM) strictly follows the "scrap and build" policy insofar as plantilla items are concerned;

WHEREAS, the DBM will await for the approval by the VSU Board of Regents for the conversion of the vacant Professor VI position and the creation of the University Professor position "*before releasing the Notice of Organization Staffing and Compensation Action (NOSCA) for the ten (10) Instructor I positions*";

WHEREAS, whatever budgetary deficiency that may arise attendant to the creation of the University Professor position from the vacant Professor VI position may be augmented by the excess amount coming from the conversion of the four (4) Campus Administrator positions to ten (10) Instructor I positions;


WHEREAS, the Board is convinced of the merits of the proposal that the creation of one (1) additional University Professor Position through the conversion of a vacant Professor VI position is advantageous to the University especially to the faculty.


THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the request for the creation of one (1) additional University Professor position from the Department of Budget and Management (DBM) with the abolition of the vacant position of PROF. 6-17-1998 subject to existing rules, regulations and guidelines.
