**BOR RESOLUTION NO. 66, s. 2012**

**A RESOLUTION APPROVING THE PROPOSAL TO REVISE THE DISTRIBUTION OF  
TUITION FEE INCOME FROM THE SUGGESTED DISTRIBUTION CONTAINED IN  
CHED MEMORANDUM ORDER NO. 20, s. 2011, EFFECTIVE CY 2013**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

**WHEREAS**, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "*to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University*";

**WHEREAS**, CHED Memorandum Order No. 20, s. 2011 dated 04 August 2011 provides the necessary guidelines on the distribution of tuition fee income *subject to* the approval of the Governing Board;

**WHEREAS**, the University needs to pay the monthly wages of part-time academic teaching staff as well as the NBC 461 salary differentials of promoted regular faculty;

**WHEREAS**, there is no allocation in the General Appropriations Act for the payment of wages to part-time teaching staff;

**WHEREAS**, the Department of Budget and Management (DBM) has informed SUCs that the DBM will not be funding the salary differentials of regular faculty who got promoted on account of NBC 461 because the SUCs can afford to pay the differentials using Tuition Fee income;

**WHEREAS**, the proposal was discussed and approved by the University Administrative Council on the occasion of the 98<sup>th</sup> UADCO Meeting held last 13 November 2012 at the PhilRootCrops Training Hall, VSU Main Campus, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal to the VSU Board of Regents for Approval; and


**WHEREAS**, the Governing Board thoroughly discussed the merits of the proposal and found it in order.




