A RESOLUTION REQUESTING FOR A SPECIAL DISPENSATION FOR THE EXTENSION OF SECONDMENT OF PROF. FRANCISCO G. GABUNADA, JR. TO THE PHILIPPINE CARABAO CENTER (PCC) AT VISAYAS STATE UNIVERSITY (VSU) FOR THE PERIOD 01 OCTOBER 2011 UNTIL 30 SEPTEMBER 2012 SUBJECT TO EXISTING CSC GUIDELINES, RULES AND REGULATIONS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Section 7, Paragraph (t) of R.A. 9158 empowers the Governing Board "to develop academic arrangements with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, visiting scientists or exchange professors, scholars, researchers, as the case may be";

WHEREAS, the Executive Director of the Philippine Carabao Center (PCC), Dr. Libertado C. Cruz has requested for an additional one (1) year of secondment of Prof. Francisco G. Gabunada, Jr. covering the period 01 October 2011 until 30 September 2012;

WHEREAS, the PCC has observed the performance of the PCC at VSU under the tutelage of Prof. Gabunada considering that "he has demonstrated excellent leadership to the committed and determined staff of the PCC at VSU in their pursuit of attaining the Center's targets and goals";

WHEREAS, under the leadership of Prof. Gabunada, the PCC at VSU was transformed into a "model buffalo dairy farm with top performing herd, enrolled in the National Genetic Improvement Program national recoprding system, with organized herd records, and sustainable system of feed resource production";

WHEREAS, the Board of Trustees Resolution No. 9, s. 2001 dated 20 January 2001 limits the duration of secondment of faculty to only three (3) years;

WHEREAS, the University would like extend the secondment of Prof. Francisco G. Gabunada to the Philippine Carabao Center at VSU for one (1) more year as requested by the PCC Executive Director, Dr. Libertado C. Cruz.
