


BOR RESOLUTION NO. 93, s. 2011





WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to fix and adjust salaries of faculty members and administrative officials and employees ..." as stipulated in Section 7, Item (h) of R.A. 9158;

WHEREAS, the Visayas State University has to renew casual/contractual employees in accordance with existing Civil Service Rules and Regulations;

WHEREAS, the Department Heads, Deans and Center Directors have recommended the renewal of the appointments of the 89 casual and 29 contractual employees;

WHEREAS, Office of the Director for Administration and Human Resource Development (ODA-HRD) has gone over the qualifications and the performance of the casual/contractual employees and has found them to be within the acceptable standards set for the various job positions;

WHEREAS, the ODA-HRD is recommending to the University President the renewal of the appointments of the 89 casual and 29 contractual employees; and

WHEREAS, the University President has approved the renewal of appointments of the 89 casual and 29 contractual employees and is endorsing the same to the Board of Regents for Confirmation *subject to* existing rules, regulations and guidelines governing such appointments.





THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Confirm the renewal of appointments of the casual/contractual employees recommended by the HRMDO, effective on the dates indicated.
