#### BOR RESOLUTION NO. 8, s. 2013

A RESOLUTION APPROVING THE REVISION OF THE BACHELOR OF ELEMENTARY EDUCATION (BEEd) AND THE BACHELOR OF SECONDARY EDUCATION (BSEd) CURRICULA IN THE MAIN CAMPUS, EFFECTIVE 1<sup>st</sup> SEMESTER SY 2013-2014

**WHEREAS**, Section 4, Paragraph (i) of R.A. 8292 empowers the Governing Board "to approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils, as hereby provided";

WHEREAS, Section 10 of Republic Act No. 8292 – The Academic Council - stipulates the powers of the Academic Council to wit: "The academic council shall have the power to review and recommend the curricular offerings and rules of discipline of the university or college subject to the appropriate action of the Board of Regents/Trustees. It shall fix the requirements for the admission of students as well as for graduation and the conferment of degrees, *subject to* review and/or approval of the Board of Regents/Trustees through the President of the university or college";

WHEREAS, the Commission on Higher Education (CHED) issued CHED Memo. Order No. 30, s. 2004 dated September 2004 containing the Revised Policies and Standards for Undergraduate Teacher Education Curriculum for the purpose of rationalizing the undergraduate teacher education in the country;

WHEREAS, the College Academic Councils of the College of Education and the College of Arts and Sciences of the Main Campus have reviewed and favorably recommended to the University Academic Council the approval of the proposal pursuant to CHED Memorandum Order No. 30, series of 2004;

**WHEREAS**, the University Academic Council met on 26 February 2013for its 33<sup>rd</sup> UAC meeting for the purpose of reviewing the proposal and the UAC has determined that the proposal is in line with the CHED requirement and favorably recommended to the University Board of Regents the approval of the proposal.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the revision of the Bachelor of Elementary Education (BEEd) and the Bachelor of Secondary Education (BSEd) of the Main Campus pursuant to CHED Memorandum Order No. 30, series of 2004, effective 1st Semester, SY 2013-2014.
