BOR RESOLUTION NO. 48, s. 2017

A RESOLUTION APPROVING THE REQUEST OF THE VSU ISABEL TO UTILIZE THE REMAINING BALANCE OF CY 2016 UNAPPROPRIATED COLLECTIONS FROM FIDUCIARY FEES IN THE AMOUNT OF P2,235,218.76 FOR AUGMENTATION OF PERSONAL SERVICE (PS), CAPITAL OUTLAY (CO) AND MAINTENANCE AND OPERATING EXPENSES (MOOE) SUBJECT TO EXISTING POLICIES AND GUIDELINES GOVERNING THE USE OF SUCH FUNDS

WHEREAS, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University";

WHEREAS, Section 7, Paragraph (f) of R.A. 9158 empowers the Governing Board "to authorize the construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties, including necessary supplies, materials and equipment...";

WHEREAS, the VSU Isabel would like to utilize said funds as follows:

 - 2. Printing & Binding Expenses P32,650.00;
 - 3. Office Supplies P27,000.00;
 - 4. Other Supplies P58,223.00;
 - 5. Other MOOE P186,961.00;
 - 6. General Services P376,320,00;
 - 7. Labor and Wages P139,940.00;
