**BOR RESOLUTION NO. 29, s. 2015**

**A RESOLUTION APPROVING THE REVISION OF THE  
QUALIFYING STANDARDS FOR ACADEMIC POSITIONS**

**WHEREAS**, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board *“to appoint, upon recommendation of the President of the University, vice-presidents, deans, directors and heads of departments, faculty members and other officials and employees of the University”*;

**WHEREAS**, Section 7, Paragraph (v) of R.A. 9158 empowers the Governing Board *“to establish policy guidelines and procedures for participative decision-making and transparency within the University”*;

**WHEREAS**, there is a need to synchronize with the Civil Service Commission (CSC) and National Budget circular (NBC) requirements insofar as educational requirements for faculty positions are concerned;

**WHEREAS**, relevant “doctoral degree” will apply only to the Professor IV position and above;

**WHEREAS**, the Philippine Regulations Commission (PRC) eligibility requirement will only indicate “if applicable” meaning that it will not be mandatory to all positions;

**WHEREAS**, the revised qualifying standards for faculty positions conforms with the CSC and NBC requirements for such positions;


**WHEREAS**, the proposal was discussed and approved on the occasion of the 112<sup>th</sup> UADCO Meeting held last 23 February at the University Guest House, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the Revised Qualifying Standards for Academic Positions, as presented.






