## BOR RESOLUTION NO. 39, s. 2009

A RESOLUTION CONFIRMING THE
MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO
BY AND BETWEEN THE VISAYAS STATE UNIVERSITY (VSU)
AND THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) FOR
THE CREATION OF A PUBLIC EMPLOYMENT SERVICE OFFICE (PESO)

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to develop consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the University" as stipulated in Item (s), Section 7 of R.A. 9158;

WHEREAS, the Visayas State University finds it advantageous to have its own Public Employment Service Office (PESO) within the VSU Main Campus in Baybay, Leyte in furtherance of its desire to help its graduates and other qualified persons in the locality find gainful employment;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the Memorandum of Agreement (MOA) between the Visayas State University and the Department of Labor and Employment for the establishment of a Public Employment Service Office (PESO) at the VSU Main Campus, Baybay, Leyte..
