A RESOLUTION CONFIRMING THE NEW APPOINTMENT OF MR. ANDY PHIL D. CORTES, VSU MAIN CAMPUS UNDER TEMPORARY STATUS EFFECTIVE ON THE DATE INDICATED AND SUBJECT TO EXISTING POLICIES, RULES AND GUIDELINES ON SUCH APPOINTMENT

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the Visayas State University needs to appoint qualified academic staff to teach the different courses in the University;

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the issuance of a new appointment under Temporary Status to Mr. Andy Phil D. Cortes;
