BOR RESOLUTION NO. 80, s. 2016

**A RESOLUTION APPROVING THE PROPOSAL TO INCREASE THE STUDENT
TEACHING FEE FROM P500.00 TO P1,000.00 EFFECTIVE
1ST SEMESTER, SCHOOL YEAR 2016-2017**

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University *"to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines"*;

WHEREAS, among other powers granted to the Board of Regents is the power *"to fix the tuition fees and other necessary school fees and charges such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as it may deem proper and reasonable to impose after due consultations with the involved sectors"* as stipulated in Item (d), Section 7 of R.A. 9158;

WHEREAS, student teaching is a college-supervised instructional experience of an undergraduate BEEd and BSEd program where theories and concepts learned in the classroom are applied in a formal setting;

WHEREAS, the University has been continuously deploying student teachers to cooperating schools every semester;

WHEREAS, there is a need to charge a higher Student Teaching Fee for BEEd and BSEd students undertaking their Practice Teaching – PRED 200 in different public and private schools to encourage cooperating teachers and institutions to continue guiding our student teachers in their role as a pre-service teacher; and

WHEREAS, the proposal was discussed and approved on the occasion of the 121st UADCO Meeting held last 24 August 2016 at 1st Floor, Center for Continuing Education (CCE), VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the increase in the Student Teaching Fee from P500.00 to P1,000.000 for all students enrolling in PRED 200 – Student Teaching effective in the 1st Semester, School Year 2016-2017.




