**BOR RESOLUTION NO. 37, s. 2016**

**A RESOLUTION APPROVING THE QUALITY MANUAL OF 2015  
OF THE VISAYAS STATE UNIVERSITY**

**WHEREAS**, Republic Act 9158 converted the then Visayas State College of Agriculture (ViSCA) into a state university, the Leyte State University, on 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, among other powers granted to the Board of Regents is the power *"to enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University"* as stipulated in Section 7, Paragraph (a) of R.A. 9158;

**WHEREAS**, the Commission on Higher Education (CHED) has classified the Visayas State University as a Level IV Higher Education Institution (HEI);

**WHEREAS**, the VSU is the first HEI in the country to be given Level II Institution Accreditation by the Accrediting Agency for Chartered Colleges and Universities (AAACCUP);

**WHEREAS**, VSU is also recognized by the AACCUP as one of the top institutions with the most number of Level III-accredited academic programs as of 2014;

**WHEREAS**, the CHED has awarded Center of Excellence (COE) status on VSU's BS Agriculture and Center of Development (COD) on its BS Development Communication;

**WHEREAS**, VSU is aiming to secure an International Standardization Organization (ISO) Certification and this Quality Manual contains the General Requirements and Management Processes leading to the development of a Quality Management System in the University;

**WHEREAS**, a Quality Management System Committee and an Internal Audit Committee have been created to facilitate ISO Certification;

**WHEREAS**, Section 10 of R.A. 9158 stipulates that it is the duty of the Administrative Council *"...to review and recommend to the Board policies governing the administration, management and development planning of the University"*; and


**WHEREAS**, the proposal was discussed and approved on the occasion of the 116<sup>th</sup> UADCO Meeting held last 16 November 2015 at the University Review Center, 2/F Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO is strongly endorsing the proposal for Approval by the VSU Board of Regents.

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the Quality Manual of 2016 of the Visayas State University, effective upon Board approval.


