**BAC RESOLUTION RECOMMENDING TO THE HOPE TO AWARD THE SUPPLY  
AND DELIVERY OF LIGHT DELIVERY VAN (REBID-GOODS-20-03)**

**WHEREAS**, the VISAYAS STATE UNIVERSITY through its Bids and Awards Committee posted on 3 January 2020 in the PhilGEPS, VSU Website's Transparency Seal and in conspicuous places within the premises of the Visayas State University an Invitation to Bid for the Supply and Delivery of **one (1) unit of LIGHT DELIVERY VAN (REBID - GOODS-20-03)** with a total Approved Budget Contract of **One Million One Hundred Sixty Thousand Pesos (Php 1, 160, 000.00)**;

**WHEREAS**, the source of funds was from the Special Trust Fund;

**WHEREAS**, on 28 January 2020, two (2) bidders submitted their bids: Toyota Tacloban Leyte, Inc. and Fast Autoworld Philippines Corporation;

**WHEREAS**, upon checking their submitted Legal/ Financial Documents and also their respective Technical Documents, the two bidders were rated passed and qualified to join the bidding;

**WHEREAS**, after ascertaining the bids and ranked, the BAC identified the **Lowest Calculated Responsive Bid (LCRB)** as shown below:

Fast Autoworld Philippines Corporation	1, 158,000.00	New L300 CAB and Chassis Euro 4; complied to all parameters of the specifications

**WHEREAS**, the BAC Chairman assigned members of the BAC and BAC Secretariat to investigate the competence of the bidders with the LCB/LCRB and conduct the post-qualification on their performance of ongoing and completed government and private contracts;

**WHEREAS**, on 30 January 2020, after the evaluation of bids and specifications of the offered brand and model and the verifications and validation of technical requirements, the BAC declared that Fast Autoworld Philippines Corporation had offered the nearest body type of the light delivery van that suits the body refitting the procuring unit required;


**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, hereby **Resolve**, as it is hereby **RESOLVED**:

- b) To recommend to the HOPE of the Visayas State University the forgoing findings.


