A RESOLUTION CONFIRMING THE RENEWAL OF APPOINTMENTS OF THREE

TO EXISTING POLICIES, RULES AND GUIDELINES ON THIS MATTER AND

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Visayas State University needs to renew the contracts of qualified academic faculty to teach the different courses in the University;

WHEREAS, the College Deans through the Vice President for Academic Affairs have recommended the renewal of the selected temporary academic faculty;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualifications of the appointees and the Human Resource Management Office (HRMO) has recommended to the University President the renewal of the contractual appointments of the following faculty:
