BOR RESOLUTION NO. 27, s. 2011

**A RESOLUTION APPROVING THE
PROPOSAL TO INSTITUTE A NEW SCIENCE SUBJECT,
ECON 11 – GENERAL ECONOMICS WITH LAND REFORM AND TAXATION**

WHEREAS, the Visayas State College of Agriculture (ViSCA) was converted into the Leyte State University (LSU) by virtue of Republic Act 9158 last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 6, of R.A. 9158 stipulates, to wit: *“The Board shall promulgate policies in accordance with the declared State policies on education and other pertinent provisions of the Constitution on education, agriculture, science and technology, as well as the policies, standards and thrusts of the CHED under Republic Act No. 7722”*;

WHEREAS, the Commission on Higher Education (CHED) has issued CHED Memorandum Orders (CMOs) specifying the minimum standards for different program offerings including the list of subjects that have to be taken for the different degree programs covered by the CMOs;

WHEREAS, the Visayas State University is cognizant of the new CHED requirements as embodied in the CMOs but also has to carefully integrate these new requirements into the different degree programs of the University in compliance with the CMOs;

WHEREAS, Section 11 of R.A. 9158 stipulates that it is the duty of the Academic Council *“...to review and recommend curricular offerings and fix the requirements for the admission to the University, as well as for graduation and the conferment of degrees, subject to the approval of the Board...”*;

WHEREAS, the proposal was presented during the 27th University Academic Council (UAC) Meeting held last 22/25 February 2011 at the University Convention Center, VSU Main Campus, Visca, City of Baybay, Leyte.


WHEREAS, the UAC passed UAC Resolution No. 15, s. 2011 dated 25 February 2011 strongly endorsing the proposal to the VSU Board of Regents for Approval.






