A RESOLUTION APPROVING THE INCREASE IN THE LODGING RATES AT THE VSU MANILA OFFICE

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "*to enact rules and regulations not contrary to law, as may be necessary to carry out the purposes and functions of the University*" as stipulated in Item (a), Section 7 of R.A. 9158;

WHEREAS, the University maintains a Liaison Office in Manila which provides effective liaison between the University and concerned government agencies, foreign embassies, cultural, civil and economic organizations and which also serves as "home away from home" of University employees who travel to Manila";

WHEREAS, the cost of maintaining said University facility has been increasing on account of the skyrocketing prices of materials;

WHEREAS, visiting employees have been requesting for upgraded room amenities to make their stay comfortable as well as enjoyable;


WHEREAS, the rising cost of electricity and other utilities have been eating up much needed funds of the University indicating that the present room rates are inadequate to recover the cost of lodging operations;

WHEREAS, the increase in the lodging rates effective upon the increase in the travel per diems given to University employees was unanimously approved by the University Administrative Council during the 72nd UADCO Meeting held last 19 September at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the increase in the lodging rates effective upon the increase in the travel per diems given to University employees.



PROPOSAL FOR THE INCREASE OF LODGING RATES IN VSU MANILA

Rationale:

The incessant increase in electricity as well as other utilities in the country today has forced the VSU Manila Office to raise its present room rates particularly rooms with air conditioners. While non-A/C room rates for VSU students and staff vary in cost, A/C room rates have a uniform cost for all occupants irrespective of status because it consumes the same amount of energy daily. If a prospective occupant wishes to avail of lower rates, non-A/C room is the better choice especially for VSU students and for those who opt for cheaper accommodation in the duration of their stay in VSU Manila Office.

Note:

1. Lodger(s) who intend to have the airconditioner turned on must convince other lodgers in the room to share in paying the aircon room rates. Otherwise, he/she will have the burden of paying the aircon room rates or the difference thereof.
2. Lodger(s) who intend to wash clothes will be charged additional P 5.00/pc.
3. Lodgers who intend to iron clothes will be charged additional P 10.00/pc - except officials on official business.
4. Transients who would like to use the bathroom facilities upon arrival will be charged P30.00 each.
