**A RESOLUTION
APPROVING THE APPOINTMENT OF GUEST
LECTURERS AND THE PAYMENT FOR THEIR SERVICES**

WHEREAS, the Visayas State University is one of the acknowledged institutions of higher learning in the Philippines;

WHEREAS, in its desire to be among the relevant academic institutions of higher learning, the VSU needs to offer graduate degree programs that are in line with the development goals of the country;

WHEREAS, it is current University policy that to qualify as Graduate Faculty, a faculty member must be in possession of a earned relevant graduate degree in his field of specialization before he/she can teach in the graduate level;

WHEREAS, there is an urgent need to hire "guest lecturers" who are considered experts and possess the needed competence to teach the specific topic(s) or course(s) in their field(s) of expertise;

WHEREAS, the position of "guest lecturer" is an accepted position in Universities but should be considered the exception rather than the rule;

WHEREAS, the new VSU graduate degree programs, Diploma in Land Administration and Management (DLAM), Master in Land Administration and Management (MLAM), and Master of Science in Land Administration and Management (MS LAM), require the services of experts in the fields of law, management, administration, computer science and planning;

WHEREAS, the VSU Graduate School does not have within its ranks, graduate faculty in possession of very specialized graduate degrees such as Master of Laws (LLM);


WHEREAS, Section 10 of R.A. 9158 provides that the Administrative Council "review and recommend to the Board (of Regents) policies governing the administration, management and development planning of the University"; and

WHEREAS, the University Administrative Council, on the occasion of its 86th UADCO Meeting held at the Farm and Resource Management Institute Conference Room (FARMI) last 07 September 2010 approved the proposal and is recommending the approval of the proposal by the VSU Board of Regents.


