**A RESOLUTION APPROVING THE APPOINTMENT OF
ATTY. JOSEPHINE RIMA-SANTIAGO AS VISITING LECTURER
AND CONSULTANT ON INTELLECTUAL PROPERTY RIGHTS (IPR)**

WHEREAS, the Leyte State University (LSU) is a public higher education institution in Region 8 and was identified by the World Intellectual Property Organization (WIPO) as the National Trainor on *Technology Management for Promoting the Transfer of Technology and Intellectual Property Transactions*;

WHEREAS, the LSU has already made initial arrangements with about 40 SUC Presidents for their actual attendance in a week-long seminar-workshop to be held at the LSU Main Campus, Visca, Baybay, Leyte in November 2006;

WHEREAS, the LSU is in dire need of an expert in the field of Intellectual Property Rights who shall take the lead role in the conduct of the said seminar-workshop;

WHEREAS, Atty. Josephine Rima-Santiago, is a legal expert in this field having graduated with an advanced degree of Master of Laws in Intellectual Property from the University of Turin, Italy and is the National Consultant of the WIPO for the Philippines.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the appointment of Atty. Josephine Rima-Santiago as Visiting Lecturer and Consultant on Intellectual Property Rights for the next two (2) years effective 25 August 2006 until 24 August 2008, unless sooner revoked or terminated by Higher Authorities for justifiable reasons such as, but not limited to availability of funds.






