**Whereas**, the President of the Leyte State University (LSU), Dr. Paciencia P. Milan, has been invited to the University of Hohenheim, Stuttgart, Germany for a three (3) week visit from 15 October 2006 until 04 November 2006;

**Whereas**, Pres, Paciencia P. Milan has been requested to participate in discussions on on-going collaboration between the University of Hohenheim, Daimler Chysler and LSU on the PPP Abaca Project;

**Whereas**, the University of Hohenheim will shoulder the international air fares to and from Germany of President Milan as well as full board and lodging during said official visit to UH;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED** That Dr. Paciencia P. Milan, be as she is, be permitted to travel to the University of Hohenheim, Stuttgart, Germany for three (3) weeks, from 15 October 2006 until 04 November 2006.

**ADOPTED** in the Leyte State University, Visca, Baybay, Leyte this 18<sup>th</sup> day of August 2006.


