BOR RESOLUTION NO. 13, s. 2013

**A RESOLUTION APPROVING THE REQUEST FOR AUTHORITY TO
UTILIZE UNIVERSITY INCOME IN THE SECOND QUARTER OF 2013
AMOUNTING TO PHP 28,047,000.00; AND AUTHORITY TO UTILIZE THE
AVAILABLE CASH COLLECTION IN THE AMOUNT OF PHP 21,286,212.93
TO PAY OUTSTANDING OBLIGATIONS INCURRED *SUBJECT TO EXISTING
POLICIES, RULES AND GUIDELINES ON THIS MATTER***

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to "*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*";

WHEREAS, Section 7, Paragraph (b) of R.A. 9158 empowers the Governing Board "*to receive and appropriate all sums as may be provided for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University*";

WHEREAS, based on BOR Resolution No. 32, s. 2011 which approved the Work and Financial Plan for 2011, the amount of *Php 28,047,000.00* can be used for expenses in the Second Quarter of 2013;

WHEREAS, the University was able to collect in cash the amount of *Php 21,286,212.93* covering the period 01 November 2012 to 31 January 2013 and there is a need to request for BOR Approval for the use of these funds for the payment of outstanding obligations incurred;

WHEREAS, CHED Memorandum Order No. 20, s. 2011 dated 04 August 2011 provides the necessary guidelines on its use *subject to* the approval of the Governing Board;

WHEREAS, the proposal was discussed and approved by the University Administrative Council on the occasion of the 100th UADCO Meeting held last 27 February 2013 at the 2nd Floor of the Center for Continuing Education, VSU Main Campus, Visca, City of Baybay, Leyte and the UADCO has strongly endorsed the proposal to the VSU Board of Regents for Approval.


