BOR RESOLUTION NO. 36, s. 2011

A RESOLUTION FAVORABLY ENDORSING THE PROPOSED BUDGET OF THE VISAYAS STATE UNIVERSITY (VSU), VISCA, BAYBAY CITY, LEYTE IN THE AMOUNT OF THREE HUNDRED SEVENTY-SEVEN MILLION and TWO HUNDRED SIXTY-TWO THOUSAND PESOS (PhP 377.262 Mil)

WHEREAS, the Visayas State University was created by virtue of Republic Act 9437 last April 27, 2007 which renamed the Leyte State University (created by virtue of Republic Act 9158 last 11 August 2001) which, in turn, converted the then Visayas State College of Agriculture (ViSCA) into a state university;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University "To exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines";

WHEREAS, Paragraph (a), Section 7 of R.A. 9158 provides: "To enact rules and regulations, not contrary to law, as may be necessary to carry out the purposes and functions of the University";

WHEREAS, the proposed budget has been presented and deliberated upon in the Special University Administrative Council (UADCO) meeting held at the University Convention Center, VSU Main Campus, Visaca, City of Baybay, Leyte last 14 April 2011;

WHEREAS, the UADCO has found that the proposed VSU Budget for FY 2012 to be reasonable and true to the budgetary requirements of the University which will undoubtedly redound to the realization of the University's Mission and Vision, thus, is strongly endorsing the proposed Budget for FY 2012 to the VSU Board of Regents for APPROVAL;

WHEREAS, the said Budget for 2012 has been perused and reviewed by the Honorable Chairperson and the Honorable Members of the VSU Board of Regents;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the amount of Three Hundred Seventy-Seven Million and Two Hundred Sixty-Two Thousand (PhP 377.262 Mil) as the VSU Proposed Budget for CY 2012;

RESOLVED FURTHER, to favorably endorse the above-stated budget proposal to the Department of Budget and Management (DBM) and the Commission on Higher Education (CHED) for approval;
