# A RESOLUTION APPROVING THE REQUEST TO HIRE ONE ADDITIONAL LAWYER (ON RETAINERSHIP) TO STRENGTHEN THE UNIVERSITY LEGAL OFFICE

**WHEREAS**, the University Legal Office needs to be strengthened in order to fully protect the rights and interests of the University and its constituents from any and all threats to its security and patrimony;

**WHEREAS**, the Viasyas State University – Main Campus, currently has in its employ one (1) lawyer, paid on retainership basis, for the purpose of providing the University with legal counsel as well as represent the University and its employees (*in their official capacities*) in the event of a court litigation;

**WHEREAS**, the University is now besieged with a lot of legal issues as well as court litigation, in furtherance of the interests of the University and its constituents;

**WHEREAS**, the existing lady lawyer is in need of an assistant who may also provide legal counsel as well as represent the University and its employees (*in their official capacities*) in case of court litigation;

**WHEREAS**, the Governing Board (GB) is authorized under R.A. 8292 and R.A. 9158 to "receive and appropriate all sums as may be provided and authorize the disbursement of all income of the University provided that it is for the benefit of the institution"; and

WHEREAS, the GB after careful perusal of the proposal, is convinced that the proposal is meritorious and urgent;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve the Request to Hire One (1) Additional Lawyer (on retainership) to Strengthen the University Legal Office, as proposed.
