BOR RESOLUTION NO. 14, s. 2012

A RESOLUTIONAPPROVING THE HIRING OF AN e-LEARNING CONSULTANT/DEVELOPER FOR A PERIOD OF SIX MONTHS PROVIDED THAT THE PROVISIONS OF REPUBLIC ACT 9184 AND ITS IMPLEMENTING RULES AND REGULATIONS (IRR) ARE STRICTLY FOLLOWED

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, the Visayas State University, Main Campus, is in need of an e-Learning expert who can develop a software program for the VSU On-Line Education Program and who can act as consultant for the actual implementation of the developed computerized system;

WHEREAS, among other powers granted to the Board of Regents is the power "to set up the adoption of modern and innovative modes of transmitting knowledge such as the use of information technology, the dual system, open learning, community laboratory, etc., for the promotion of greater access to higher education" as stipulated in Section 7, Item (u) of R.A. 9158;

WHEREAS, Republic Act 9184, "An Act Providing for the Modernization, Standardization and Regulation of the Procurement Activities of Government and for Other Purposes" otherwise known as the Government Reform Procurement Act, including its Implementing Rules and Regulations (IRR), specify the necessary processes and steps to be undertaken attendant to the procurement of Infrastructure Projects, Goods and Consulting Services Subject to the provisions of Commonwealth Act No. 138 (Section 4, RA 9184);

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to Approve the hiring of an e-Learning expert who can develop a software program for the VSU On-Line Education Program and who can act as consultant for the actual implementation of the developed computerized system for a period of six months.
