BOR RESOLUTION NO. 36, s. 2009

A RESOLUTIONAPPROVING THE REQUEST
OF THE VSU ALANGALANG CAMPUS FOR AUTHORITY
TO REALIGN THE AMOUNT OF TWO HUNDRED EIGHTY
EIGHT THOUSAND PESOS (P288,000.00) FROM MAINTENANCE
AND OTHER OPERATING EXPENSES (MOOE) TO CAPITAL OUTLAY

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 and was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 7 of R.A. 9158 specifically empowers the Board of Regents of the University to exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines;

WHEREAS, among other powers granted to the Board of Regents is the power "to receive and appropriate all sums as may be provided, for the support of the University in the manner it may determine, in its discretion, to carry out the purposes and functions of the University" as stipulated in Item (b), Section 7 of R.A. 9158;

WHEREAS, the College of Environmental and Agricultural Technology (CEAT), VSU Alangalang Campus, has embarked on Phase 1 of the Road Pavement Project inside the campus as part of its campus development;

WHEREAS, the Head of the CEAT Physical Plant and Facilities Office estimates that Phase 1 of the project will cost about P288,000.00;

WHEREAS, the College Dean has identified the realignment of the MOOE of the College to Capital Outlay as the possible fund source for the project;

WHEREAS, the University Administrative Council during its 76th UADCO Meeting held last 11 June 2000 discussed this proposal and has recommended the approval of the proposal, effective upon BOR approval.

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to approve the proposed request of the College of Environmental and Agricultural Technology, VSU Alangalang Cmapus for the realignment of Maintenance and Other Operating Expenses (MOOE) to Capital Outlay in the amount of *TWO HUNDRED EIGHTY EIGHT THOUSAND Pesos* and *00/100* (P288,000.00), effective upon BOR approval.
