**BOR RESOLUTION NO. 56, s. 2009**

**A RESOLUTION AMENDING  
BOR RESOLUTION No. 48, s. 2009 DATED  
10 AUGUST 2009 COVERING THE RATIONALIZATION  
OF THE COLLECTION OF LEGACY FUND FROM VSU GRADUATES**

**WHEREAS**, the Governing Board (GB) is authorized under R.A. 8292 and R.A. 9158 to “receive and appropriate all sums as may be provided and authorize the disbursement of all income of the University provided that it is for the benefit of the institution”;

**WHEREAS**, the Visayas State University (VSU) Board of Regents (BOR) passed BOR Resolution No. 48, s. 2009 dated 10 August 2009 indicated that the amount to be collected from each level has to be rationalized based on the capacity to pay of each level;

**WHEREAS**, BOR Resolution No. 48, s. 2009, nevertheless, stipulates that the approval of the proposal “*Rationalization of the Collection of Legacy Fund from VSU Graduates*” will be dependent on consultation and approval of the affected students;

**WHEREAS**, the University Supreme Student Council (USSC) of the Visayas State University conducted consultations with the affected students through the Student Representatives in each of the colleges of the Main Campus;


**WHEREAS**, the Student Representatives reported that the overwhelming majority of affected students expressed their strong disapproval of the proposed increase in Legacy Fee collection on account of the very tight economic situation of their parents because of the national and global economic crisis;


**WHEREAS**, the Governing Board is aware of the need to rationalize the collection of the Legacy Fund from graduating students but with due consideration of the sentiments of the students currently enrolled in the University especially the graduating students;

**THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED** to Amend BOR Resolution No. 48, s. 2009 dated 10 August 2009 in view of the disapproval by the affected students of the approved new rates, such that collection of the new rates shall become effective for all transferees to VSU as of 2<sup>nd</sup> Semester SY 2009-2010 and all incoming freshmen students for SY 2009-2010.



WHEREAS, The USSC officers disagree with the proposal in view of the fact that it would affect the imbursements of the students and the proposed rate is too high;


WHEREAS, From a random consultation among VSU students, their reaction was unenthusiastic towards the matter;
