**BOR RESOLUTION NO. 71, s. 2014**

**A RESOLUTION CONFIRMING THE CHANGE IN APPOINTMENT STATUS OF SEVEN (7) ADMINISTRATIVE STAFF FROM VSU MAIN CAMPUS FROM CASUAL TO REGULAR, EFFECTIVE ON THE DATES INDICATED *SUBJECT TO* EXISTING POLICIES, RULES AND GUIDELINES GOVERNING SUCH APPOINTMENTS**

**WHEREAS**, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

**WHEREAS**, Section 4 of R.A. 9158 specifically provides that the University “*shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents*”;

**WHEREAS**, Section 7 of R.A. 8292 empowers the Board to “*exercise all the powers granted to the Board of Directors of a corporation under Section 36 of Batas Pambansa Blg. 68, otherwise known as the Corporate Code of the Philippines*”;

**WHEREAS**, among other powers granted to the Board of Regents is the power “*to fix and adjust salaries of faculty members and administrative officials and employees ...*” as stipulated in Section 7, Item (h) of R.A. 9158;

**WHEREAS**, the University regularly awards regular plantilla items to its administrative employees whenever these position are available;

**WHEREAS**, the Non-Academic Personnel Board (NAPB), the Selection and Promotion Board for Administrative Personnel of the Visayas State University, after careful deliberation, has determined that the following administrative personnel with Casual Appointments, have met and are in possession of the required qualifications for their appointment to regular plantilla item positions in accordance with CSC and University policies and guidelines;


