BOR RESOLUTION NO. 90, s. 2014

A RESOLUTION CONFIRMING THE NEW APPOINTMENT MR. ROMMEL M. GARRIDO, JR. ON CONTRACTUAL STATUS EFFECTIVE ON THE DATE INDICATED AND SUBJECT TO EXISTING RULES, REGULATIONS AND GUIDELINES GOVERNING SUCH APPOINTMENTS

WHEREAS, the Leyte State University was created by virtue of Republic Act 9158 which converted the then Visayas State College of Agriculture (ViSCA) into a state university last 11 August 2001 which was later renamed Visayas State University (VSU) by virtue of R.A. 9437;

WHEREAS, Section 4 of R.A. 9158 specifically provides that the University "shall have the general powers of a corporation as set forth in the Corporation Law. The Administration of the University and the exercise of its powers shall be vested exclusively in the Board of Regents";

WHEREAS, Section 7, Paragraph (g) of R.A. 9158 empowers the Governing Board "to appoint, upon the recommendation of the President of the University, vice-presidents, deans, directors, heads of department, faculty members and other officials and employees of the University";

WHEREAS, the Visayas State University needs to hire qualified academic faculty to teach the different courses in the University;

WHEREAS, the Academic Personnel Committee of the Department of Plant Breeding and Genetics (DPBG) through the Vice President for Academic Affairs have recommended the appointment of Mr. Rommel M. Garrido, Jr. as new contractual academic faculty in lieu of Ms. Julien A Resos who is on study leave;

WHEREAS, University Academic Personnel Board (APB) has gone over the qualification of the appointee and the Human Resource Management and Development Office (HRMDO) has recommended to the University President the issuance of a new appointment charged to Lump Sum appropriation to Mr. Rommel M. Garrido, Jr.

WHEREAS, the University President has approved and issued the appointment and is endorsing the same to the Board of Regents for <u>Confirmation</u> Subject to existing rules, regulations and guidelines governing such appointments;

THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED to confirm the new contractual appointment of Mr. Rommel M. Garrido, Jr. charged to Lump Sum appropriation effective on the date indicated.
